The Ministry of Health and Family Welfare, Government of India has issued an Office Memorandum dated 5th March, 2020 as advisory cautioning against mass gathering and the World Health Organisation has also declared Novel Coronavirus (COVID-19) as global pandemic advising against mass congregation.
